Tuition is drafted on the **20th** of each month, unless date falls on a holiday or weekend. In these cases, account will be drafted on the next business day following draft date.

If your financial institution refuses automatic deduction, a fee of **\$30** will be assessed by Orangeburg Preparatory Schools, Inc. Additional fees may be imposed by your financial institution. If unable to deduct sufficient funds on the draft date, tuition(s) will need to be paid by check, money order, cash, or credit card. If a second insufficient draft occurs, the student(s) account(s) may result in a cash only status.

This authorization will remain in full force and effect until Orangeburg Preparatory Schools, Inc. has received written notification of its termination in such time and manner as to afford Orangeburg Preparatory Schools, Inc. a reasonable opportunity to take action.

By signing this authorization, I (we) agree to the terms and conditions and grant Orangeburg Preparatory Schools, Inc. the authority to automatically debit monthly tuition payments from my (our) account.

Please note: Tuition payments for the 2024-2025 school year begin June 1, 2024, and may be made monthly, quarterly or yearly. If a student enrolls after June 1, the following rates will be prorated by the number of days remaining in the school year.

This contract is subject to the following conditions and financial obligations:

- I understand there is a **\$500 Building Fee** requirement for every student. **The non-refundable \$100 Building Fee is due with the contract every year for five years until the \$500 building fee requirement is met.**
- I understand there is an annual **\$250 Technology Fee** to be paid per semester: **\$125 is due by June 1st and \$125 is due by January 7th.**
- I understand there is a **\$150 re-enrollment fee** if my contract is not turned in by **June 1.**
- I understand the school has the right (1) to determine the class, the homeroom, and the work level to which the student shall be assigned; (2) to suspend or expel the student for any disciplinary reason or cause, and agree that the school shall be the sole judge of the sufficiency of such reason or cause.
- I understand that the student shall be subject to and in conformity with the rules as set forth in the Orangeburg Preparatory Schools, Inc., handbook and any other rules adopted by the school.
- I will pay the sum per year for each student's tuition, payable in annual, monthly or quarterly installments beginning **June 1, 2024.** Subsequent payments are due on the first day of each month or quarter. If paying quarterly, the due dates are the first day of June, September, December, and March.
- I will pay a service charge of **\$30.00** per month on all accounts 20 days past due unless other financial arrangements are approved. The monthly payment must be received (not post-marked) in the Lower or Upper Campus office by the 20th of each month to avoid service charges. Access to academic communications (Gradelink, Report Cards, etc.) will be restricted on all past-due accounts. I will pay a fee of **\$35.00** on any check returned from a banking institution.
- I understand that a **3.5% credit card convenience fee** will be charged to all credit card transactions. I also understand that a flat rate of **\$3.00** will be added to each **debit card** transaction.
- I understand that my obligation to pay the charges for the full academic year is unconditional and that upon a breach of this contract, the school reserves the right to commence a collection action for the full amount due, plus collection costs and reasonable attorney's fees, if applicable, notwithstanding subsequent absences, withdrawal, or dismissal from school of the above student.
- However, if a student is withdrawn from school or a request for cancellation of contract is made, no collection efforts for the balance will be commenced if the account is brought current and a **\$500.00** cancellation fee is paid. Transcripts/records will be released when account balances are paid in full.
- This contract is binding in its entirety. Please retain a copy of this contract for your records.
